Day One, SUNDAY – Departure from Dublin and arrival in France

Ryanair flight from Dublin to Paris. On arrival, Kieran will gather the group and together you will be taken to our private coach. Transfer to our accommodation in a religious guesthouse in the centre of Lisieux (3 hr drive). Check-in. Celebration of Mass, dinner and overnight.

Day Two, Monday – The Carmel of Lisieux, Les Buissonnets

Breakfast at leisure. This morning, we will visit the Carmelite monastery where St Thérèse is buried. Mass celebration. Visit the museum of Carmel that contains, among other things, the testimonies of many soldiers who credited the Little Flower for saving their lives during the First World War. Free time for lunch. Afterwards, we will visit Les Buissonnets, the family home of the Martin family. Dinner at the accommodation.

Day Three, TUESDAY – The Basilica of St Thérèse, the Cathedral of Lisieux

The Basilica of St Thérèse is a magnificent building with beautiful side chapels dedicated to many national churches, including Ireland. There are major relics of St Thérèse here, as well as the tombs of her parents, Louis and Zeliè Martin. Mass celebration. Free time for lunch. Afternoon visit to the historic Cathedral of Lisieux where the Little Flower received her First Communion. Dinner at the accommodation.

Day Four, WEDNESDAY – Transfer to Paris, Rue du Bac

After breakfast, load coach and transfer to Paris. Mass at the church of Rue du Bac, where the incorrupt body of St Catherine Labourè can be venerated. St Catherine received the revelation from Our Lady regarding the Miraculous Medal. As a result, Rue du Bac is one of the most important pilgrimage shrines in France. Free time for personal prayer and lunch. Check-in at our three-star hotel in the centre. Walking tour of some historic sights, including the Pantheon and Notre Dame. Free time for dinner.

Day Five, THURSDAY – Notre Dame, Sacre Coeur

After breakfast, Mass in the newly rebuilt Cathedral of Notre Dame, followed by ample time to visit France's most historic church. Free time for lunch. Afternoon visit to Sacre Coeur, the shrine to the Sacred Heart located on the hill of Montmartre, two hundred meters above the Seine. The basilica, a national monument, has a view of the entire city of Paris and its suburbs. Adoration of the Blessed Sacrament. Return to hotel. Free time for dinner.

Day Six, Friday - Departure

Check out from our hotel. Some free time this morning. Transfer to Paris airport. Check in for our Ryanair flight to Dublin.
